## Grant Reporting HEERF II and HEERF III for Quarter Ending March 31, 2022 FINAL Published Date: April 8, 2022

The Higher Education Emergency Relief Funds (HEERF II and HEERF III) are authorized by the Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRRSAA), Public Law 116-260, signed into law on Dec. 27, 2020 and the American Rescue Plan (ARP) Public Law 117-2, signed into law on March 11, 2021. In total, the CRRSAA authorizes \$81.88 billion, and ARP authorizes \$39.6 billion in support for education in addition to the \$30.75 billion expeditiously provided last spring through the Coronavirus Aid, Recovery, and Economic Security (CARES) Act, Public Law 116-136.

Shor Yoshuv Rabbinical College has signed and returned the Certification and Agreement and assures that the institution has used or intends to use the applicable amount of funds designated under the CRRSAA and ARP programs to provide Emergency Financial Aid Grants to Students.

Unlike the CARES Act, the CRRSAA and ARP require that institutions prioritize students with exceptional need, such as students who receive Pell grants, in awarding financial aid grants to students. However, students do not need to be Pell recipients nor do they need to be eligible for Pell grants to be eligible to receive HEERF grants.

Shor Yoshuv Rabbinical College has been allocated \$29,899 under CRRSAA and \$92,305 under ARP to be used as Emergency Financial Aid Grants to students. Shor Yoshuv Rabbinical College has disbursed \$13,499 from the Student Portion of CRRSAA and \$92,305 from the Student Portion of ARP as grants to 285 eligible students between January 1, 2022 and March 31, 2022.

The total number of students eligible to receive ARP funding in Shor Yoshuv Rabbinical College in this quarter is 285. This includes the number of eligible degree seeking and non-degree seeking students who were enrolled for the Fall 2021 semester and who were currently enrolled at the time of disbursement of the funds.

The method used by Shor Yoshuv Rabbinical College to prioritize students with exceptional need was based on the following criteria:

Students that submitted FAFSA applications which indicated financial need were prioritized and were the first students to receive ARP grants. After those students were awarded, ARP Grants were awarded to the other degree seeking students. Dependent students received awards of \$300, and students who enrolled for the Spring 2021 semester who did not yet receive previous grants received an additional \$100 award. Shor Yoshuv Rabbinical College then awarded the non-degree seeking students. Independent students were awarded a grant of \$800 and dependent students were awarded \$300. Students who enrolled after the initial enrollment period of the semester received grants of \$150.

Students were instructed that their Emergency Financial Aid Grants are non-taxable and may be used for any component of their cost of attendance or for emergency costs that arise due to coronavirus, such as tuition, food, housing, health care (including mental health care) or child care.
